## **EDUCATION LAW SECTION 2-D GUIDANCE FOR CLINICAL EXPERIENCES IN EDUCATOR PREPARATION PROGRAMS**

In a [memo to the field](#), the New York State Education Department confirms that the placement of a candidate in an educational agency (school, school district, and BOCES) for clinical experience does not require an Education Law section 2-d agreement. Additionally, the memo provides guidance as to how educational agencies can address concerns regarding candidates and the privacy and security of student data. The recommended best practices for Education Law section 2-d compliance include providing candidates with appropriate training about student data privacy and entering into a memorandum of understanding or similar collaborative agreement that addresses the protection of student personally identifiable information and other issues. The memo, a sample privacy and security training presentation, a sample candidate confidentiality and non-disclosure agreement, and other resources for educator preparation programs are available on the [Office of College and University Evaluation website](#).

## **ALTERNATIVE MODELS OF CLINICAL EXPERIENCES**

Given the current status of the pandemic, the Department does not intend to extend the alternative models of clinical experiences beyond the Summer 2022 term. However, candidates may engage in remote learning with students during their field experiences and student teaching if they are placed in schools that utilize this method of learning, as long as the clinical experiences meet the program requirements and teacher preparation program regulations (e.g., student teachers gradually assume increased responsibility for instruction, classroom management, and other related duties). Videos and case studies could not replace field experiences and student teaching after the current flexibility ends. The Department will continue to closely monitor school activities in the context of the pandemic and determine if any clinical experience flexibilities are needed.

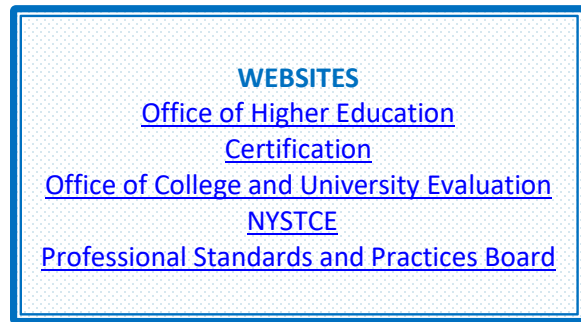
### **NEW DIRECTOR OF THE OFFICE OF COLLEGE AND UNIVERSITY EVALUATION**
